This email letter defines our agreement regarding publication of your story, poem, essay, review or graphic _____ (“the Work”) in a future issue of the Gator Springs Gazette (“GSG”).

Within 12 months of today’s date, Fandango Virtual will publish the Work in the bi-monthly print version of Gator Springs Gazette. Within three months following the release of the print version, all of the works therein will appear in the online version of GSG and will be available for viewing for a period of one year from the date of publication. Future GSG anthologies (CD or print) may contain the Work.

You grant Fandango Virtual the sole and exclusive right to publish the Work in the print version and the above-mentioned electronic format for distribution in the English language. You also grant non-exclusive rights for inclusion in any future anthologies. The online version may remain archived for a year or longer in some cases.

Before the Work is published and for 1 months after it appears online (“the Natural Run”), you agree not to publish the Work in any other online or print magazine. GSG is open to flexible arrangements with prior agreement such as inclusion of the work in an author’s collection or on the author’s personal website. After the Work has completed its Natural Run, all rights will revert to you, though we appreciate being credited as first publisher. If for any reason Fandango Virtual fails to publish the Work within 12 months from today’s date, all rights will automatically revert to you.

You hereby warrant to us that you have created the Work, that you are the sole and exclusive owner of the rights to the Work and that you have the full power to grant the rights herein conveyed to us. You hereby grant Fandango Virtual the right and authority to use your name on the Work and in all promotion and publicity for the Work at Fandango Virtual's sole discretion.

Before the Work appears in its final form, editors will make every effort to consult with the contributor before making changes which materially affect the artistic integrity of the Work. You hereby grant permission for the editors to make minor changes, including but not limited to correction of typographical errors, changes in font, paragraph, formatting, layout adjustments and conformity to GSG style protocols without further consultation.

At this time GSG offers no payment for inclusion in any editions but one complimentary author copy will be sent to the address on file. As a contributor, you may purchase additional copies at a reduced rate on the Contributor Purchase Page after the print release is announced online.

- a 50-word third person bio. Bios may include publication credits and list any awards or published books. We will also be happy to include a link to your website on the online version. We reserve the right to edit bios in keeping with GSG protocols and depending on space constraints.
- an e-mail address, which may be published in the bio (or, alternatively, state that you would prefer not to publish an e-mail address).
- a snail mail address including your legal name. This address will be kept on file but neither distributed nor sold to any third parties. Your legal name will be held as confidential. If no address is supplied, you will not be eligible to receive your contributor copy or other possible GSG windfall. If you move, please let us know of the change of address.

Your name will be added to the Fandango Virtual mailing list, which will be used to inform you of publication releases and other news associated with the publisher. You may opt out of this list at any time using the link on the bottom of such mailings, but future acceptances will result in your name being added back to the list.
